##### **1.0 Introduction**

The Osun State Government through the Ministry of Works intends to carry out the Dualization of Akoda - Cottage Junction -Oke Gada - Ido Osun - Offatedo Junction with Spurs in Osun State.

In compliance with the provisions of the Osun State Public Procurement Law 2015, the Osun State Ministry of Works on behalf of Osun State Government, hereby invites interested, eligible and competent Contractors to bid for the Dualization of Akoda - Cottage Junction - Oke Gada - Ido Osun - Offatedo Junction with Spurs to Army Barrack and Egbedi in Osun State.

##### **2.0 Scope of Work**

The scope of work which comprises of construction of new carriageway, scarification of the existing carriageway with the reconstruction of the existing carriageway where the old alignment is maintained, construction of Hydraulic Structures as specified in the Design Drawing for the 23Km length of the road and Construction of Bridges across the Osun River on the road alignment. The execution of the Scope is scheduled to be implemented in phases.

The entire project is divided into four Lots as described below:

Lot 1: Ch. 0+00 (Akoda) - Ch. 5+00 (Baptist High Sch.)

Lot.2: Ch. 5+00 (Baptist High Sch.) - Ch. 8+854(Oke Gada Jcn.)

Lot 3: One number 2-Span Bridge and One number 3-Span Bridge

Lot 4: Ch. 8+854 (Oke Gada Jcn.) - Ch. 23+300( Ofatedo Jcn) with Spur to Army Barack and Egbedi Jcn.)
